

## **Basis of the competition**

The organizer is Lloret Futur, SA (hereinafter, the organizer) with ITS registered office in Avinguda de les Alegries, n. 3, and Company Tax Number A17354333.

### **1. Object**

The purpose of this competition is to give a two-days stay as a prize, from 26th to 27th April 2019 (one night) in a hotel in Lloret de Mar. The winners will be able to carry out the activities mentioned below linked to the Lloret Cycling Weekend, for free.

### **2. Start and end date**

The competition will start on 04/03/2019 at 14:00 and end on 03/04/2019 at 23:59, both days included. Only those who have registered within the established period will be part of the draw. Once this period is over, all registrations will be considered null and void.

### **3. Participation and requirements**

Any person over 18 years of age can enter the draw after registering on <http://www.lloretcycling.com/en/lloret-cycling-weekend-2019> within the established period. Registration implies acceptance of the competition rules. Any person who has a link, whether a commercial or an employment link, with the organizer of this competition is excluded from participating. In addition, this prohibition is extended to direct relatives of the same. Failure to comply with this rule will lead to the registration being declared invalid. In the same way, those participants who do not comply with the rules of operation of the competition will be prohibited from participating in the competition.

Only those persons that correctly and accurately record their data can be chosen for the prize, with the registering party being responsible for any false or incorrect information that they enter into the system. Each person

will only be able to register for the competition once and registrations made more than once will be considered null and void.

#### **4. Prize**

The prize involves a stay in a hotel in Lloret de Mar, from 26th to 27th April 2019, in a double room including breakfast. The 5 winners may come with a friend or partner who will have the right to participate in all the activities of the prize.

The prize cannot be exchanged for its economic value and is non-transferable to another person, nor is it refundable. It will not be possible to change it to another week, it is only possible to use the prize on the weekend from 26th to 27th September 2019

On that same day 13 substitute winners will also be named. Notification of having won the prize will be carried out through email, which must be answered and accepted within 48 hours from the moment the email is sent.

In the event of not being able to notify the winner in the first instance or if no response is received, the substitute will be notified, who will also have 48 hours to respond to the email, from the moment the email is sent. In the event that the substitute winner does not respond or accept the prize within

48 hours, the prize of the corresponding stay will be considered null and void.

The organizer reserves the right to use the data provided by the winners when registering for the competition. By registering, the winner is giving his/her consent.

## **6. Additional information**

Lloret Futur, SA reserves the right to modify, at any time, the conditions of this competition, including changing the end date or changing the weekend on which the prize is to be enjoyed. Similarly, Lloret Futur, SA also reserves the right to cancel some of the aforementioned activities with there being no obligation to change the affected activity for another, as well as having the possibility of cancelling the prize in the event that irregularities are detected.
